Continuation of 11. does NOT place the application in condition for allowance because: The Applicant's arguments concerning the outstanding office action's failure to make a prima facie case of obviousness because of its failure to teach registering, decoding, and determining have been considered but are not persuasive. First, the Applicant claims that the content server is required to perform an additional step of validating the SID and therefore not equivalent to the instant invention. Although Levergood's content server does in fact validate the SID, the validation could be as simple and merely checking to make sure that the SID was in fact sent by the authentication server, which anyone knowledgeable in the field would understand is rather important. In addition, the extra step of verification would logically come after the final step in the instant invention and although not suggested by the instant invention, it has also not been forbidden. In page 4 of the Applicant's arguments, he goes on to argue that Levergood fails to teach or suggest sending a notification to said content providing server that starting a service provision for said mobile information terminal is permitted based on the authentication and SID appending step. The Examiner respectfully disagrees with the Applicant's contention and would like to draw the Applicant's attention to column 3, lines 33-48 wherein Levergood describes the use of the SID in order to signify the authentication of a request made by the client so that the requested material may be provided to the client. The SID is the authentication server's way of notifying the content server that it has already predetermined that the client is not only registered but also authorized for transactions. The Applicant next argues that Levergood's suggestion of saving SIDs locally for future access cannot reasonably be interpreted within the instant invention. The Examiner would like to draw the Applicant's attention his own citation, specifically column 5 lines 49-52 wherein Levergood briefly explains that the SID is the result of communication between the client and an authentication server, and it is the authentication server that creates the SID which is then used to notify the content server that the client has been and is authorized for the transaction requested. For the reasons given above, the Examiner has no choice but to uphold her previous rejections regarding claim 1, as well as claim 9 for substantially the same reasons.
