Continuation of 11. does NOT place the application in condition for allowance because: Applicant's remarks have been considered in their entirety but are not persuasive. Applicant argues that Cooper fails to teach or suggest generating at the web browser of the mobile device, a secret key based on the previous step of verifying the identity of an authentication server. The portions cited by the Examiner in her previous office action support the use of certificates in order for members of a system to authenticate one another before conducting transactions. Once this verification routing is complete, the device is able to generate its own key to use for future communications based on that verification. Furthermore, the storing of public keys from a variety of servers and systems within the mobile device anticipates Applicant's encryption at the web browser of the mobile device's key using a public key stored within the device corresponding to a particular server. The Examiner also respectfully disagrees with Applicant's attempts to distinguish his invention from that of Cooper by limiting Cooper to particular embodiments disclosed within his specification. Insofar as Applicant's invention was rejected in view of the reference as a whole, and numerous other portions of the reference provide for the generation of keys and more using a web browser, there is no reason to limit Cooper to a particular embodiment wherein the keys may be only be generated at a particular server and not at the user device itself. Applicant's attempts to treat particular portions of the Cooper reference as separate and distinct from the reference in its entirety are equally unpersuasive insofar the Examiner has provided a series of citations, which when taken together and in view of the reference in its entirety, anticipates Applicant's claims.
