Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments:

Applicant's representative requested how the independent claims 1 and 5 could be amended to overcome the prior art and be in condition for allowance.

Examiner suggested the proposed changes to claim 5:

A method of alerting a user of an occasion date when a call is received in a mobile phone having an idle mode screen displaying function and an incoming call ring sound alteration function, comprising:

selectively entering the occasion date, images, and ring sounds from downloaded information or from said mobile phone;

accepting a call on the mobile phone, the call intended fro the user;

checking whether today is a registered occasion date;

displaying a first predetermined image from said images for an idle mode screen on the phone for viewing by the user and playing a first predetermined ring sound from said sounds as an incoming call ring sound, if today is not the registered occasion date; and

displaying a second predetermined ring sound from said sounds as the incoming call ring sound, if the today is the registered occasion date to remind the user of the registered occasion date.

Examiner suggested the proposed hanges in claim 1 including: 'selectively entering the occasion date and images from downloaded information or from said mobile phone' .

Applicant's representative will review the proposed amendments to the claims with the applicant.
