1. This Office Action is the answer to the IDS submitted on 8/14/2006.
2. Claims 1-30, and 61 are pending.

3. The submitted formal drawings are accepted by the examiner.

Allowable Subject Matter and Reason for Allowance

4. Independent claim 1, and 61 are allowable over closest available prior art of Sherman (US Pat. 4,931,929), Berger et al. (US Pat. 6,414,693), and Knight (US Pat. 6,344,853) because these references do not make obvious to one of ordinary skill in the art to suggest a computer-implemented method to price a promotional product, or a machine-readable medium storing a sequence of instructions that, when executed by a machine, cause the machine automatically to price a promotional product by a method including:

generating a user interface that facilitates input of specification information concerning the promotional product, the specification information including product information identifying a base product to be decorated and decoration manufacturing process information identifying a process whereby a decoration is applied to the base product; and automatically calculating a price for the promotional product utilizing the product information and the decoration manufacturing process information,

In above cited references, there is no teaching or suggestion of a user interface that facilitates input of specification information including product information identifying a base product, and decorating manufacturing process information identifying a process whereby a decoration is applied to the base product; since there is no teaching of a decoration manufacturing process information, it follows that there is

no teaching or suggestion of automatically calculating a price for the promotional product utilizing the decorating manufacturing process information.

5. Claims 2-30 are allowable because they are dependent on allowed claim 1.
6. Remark: The IDS submitted on 8/14/2006 has a document for commercial application of Giftmugs.com; this document does not discuss at all about automatically calculating a price for a promotional product utilizing that product information and a decoration manufacturing process information; therefore, this document does not render obvious this pending invention.

7. Claims 1-30, and 61 are patentable. They are renumbered as claims 1-31.
