Continuation of 3. NOTE: Applicant has amended each of the independent claims (1,10,19,28, and 36). Independent claims 1,10, and 19 now recite the limitation "adjusting said acceptance window based on said largest nonce value yet seen". Further, independent claims 28 and 36 now recite the limitation "adjust said replay mask based on said largest nonce value yet seen". Thus, the independent claims, and their corresponding dependent claims, have a change in scope which would require further consideration and/or search.
