Continuation of 11. does NOT place the application in condition for allowance because: Applicant's arguments filed 09/26/2008 have been fully considered but they are not persuasive. Applicant argues that Gouda in view of Milliken does not teach adjusting the size of a range of acceptable nonce values based on a largest nonce value yet seen.

With respect to this argument, Gouda describes a system in which a window is changed based on the largest nonce value yet seen. In Gouda, when the system receives a nonce value that is larger than those yet seen it creates the double window (as described in section V.) Therefore, Gouda teaches changing the type of window based on the largest nonce value yet seen. Milliken teaches to change the size of a window for various reasons such as expected maximum delay (see column 3 lines 56-61). One of ordinary skill in the art would recognize to replace Gouda's changing of the type of window with Milliken's teaching to change the size of the window based on the largest nonce value yet seen. One of ordinary skill in the art would also recognize that this would be accomplished by including the bridge of Gouda (see section V. case iii.) in the window thereby increasing the size of the window when the window is changed based on the largest nonce value yet seen. This would result in the predictable result of preventing replay attacks within a sliding window. Therefore, the combination of Gouda and Milliken discloses adjusting the size of a range of acceptable nonce values based on a largest nonce value yet seen.
