**EXAMINER'S AMENDMENT**

The application has been amended as follows:

**Claims 9-11 & 18 are canceled.**

**Claim 21.** (New) A shielding assembly comprising:

at least first and second elongate members, each of said members joinable together at a common point;

a shield, movably mountable adjacent said shielding assembly and movable in three dimensions relative to said shielding assembly so as to shield a user of said shielding assembly; and

at least a third elongate member that forms a frame with the first and second elongate members, said shield being movably mounted relative to the first, second, and third elongate members adjacent said frame;

wherein said shield is mounted for longitudinal and transverse movement relative to each of the first, second, and third elongate members.

**Claim 22.** (New) The shielding assembly according to claim 21, wherein said shield is mounted within said frame.

**Claim 23.** (New) The shielding assembly according to claim 21, wherein said shield is lockable relative to at least one said elongate member.


**Claim 24.** (New) The shielding assembly according to claim 21, wherein said shield is moveably mountable adjacent said assembly at a region lower than said common point.
