This is a decision on the petition under the unintentional provisions of 37 CFR 1.137(b), filed April 9, 2007, to revive the above-identified application.

The petition is **DISMISSED**.

Any request for reconsideration of this decision must be submitted within TWO (2) MONTHS from the mail date of this decision. Extensions of time under 37 CFR 1.136(a) are permitted. The reconsideration request should include a cover letter entitled "Renewed Petition under 37 CFR 1.137(b)." This is **not** a final agency action within the meaning of 5 U.S.C. § 704.

The application became abandoned for failure to reply in a timely manner to the non-final Office action mailed August 14, 2006, which set a shortened statutory period for reply of three (3) months. No extensions of time under the provisions of 37 CFR 1.136(a) were obtained. Accordingly, the application became abandoned on November 15, 2006. A Notice of Abandonment was mailed on March 26, 2007.

A grantable petition under 37 CFR 1.137(b) must be accompanied by: (1) the required reply, unless previously filed; (2) the petition fee as set forth in 37 CFR 1.17(m); (3) a statement that the entire delay in filing the required reply from the due date for the reply until the filing of a grantable petition pursuant to 37 CFR 1.137(b) was unintentional; and (4) any terminal disclaimer (and fee as set forth in 37 CFR 1.20(d)) required by 37 CFR 1.137(d). Where there is a question as to whether either the abandonment or the delay in filing a petition under 37 CFR 1.137 was unintentional, the Director may require additional

information. See MPEP 711.03(c)(II)(C). The instant petition lacks items (1) and (3) above.

As to items (1) and (3) above, the reply and the petition containing the statement of unintentional delay are not considered to have been signed as the signature appearing on the reply and petition appear to be a "stamped" signature. The rule at 37 CFR 1.4(d)(2) requires "[a]n S-signature \* \* \* inserted between forward slash marks \* \* \*." The person signing the correspondence must insert his or own S-signature with a first single forward slash mark, before, and a second single forward slash mark after the S-signature. The "must insert his or her own signature" requirement is met by the signer directly typing his or her own signature using a keyboard. As the stamped signature appearing on the petition and reply is not in compliance with 37 CFR 1.4(d)(2), these papers are not considered to be properly signed. Further, the registration number must appear on the document as shown on the attached S-signatures examples.

For the above reasons, the petition under 37 CFR 1.137(b) cannot be granted at this time as compliance with 37 CFR 1.4(d)(2) has not been satisfied on either the reply or the petition.
