### DETAILED ACTION

1. This action is responsive to the Applicant's communication filed on 2/8/2007.
2. Claims 1-25 have been canceled, and claim 32 has been added.
3. Claims 26-32 are pending and presented for examination.

### EXAMINER'S AMENDMENT

27. (Currently Amended) A method of incorporating time and time zone information for a directory listing of computer files, comprising:

receiving a directory listing command for listing computer files within the directory;

and

displaying a directory listing of computer files, wherein the directory listing of computer files includes time and time zone information associated with each of the computer files;

selecting a sorting order; sorting the directory listing of computer files in accordance with the sorting order, wherein the directory listing is sorted by specified regions, wherein the specified regions comprise geographic areas defined by longitude and latitude information; and

displaying the directory listing of computer files in accordance with the sorting order.

29. (Currently Amended) A method of incorporating time and time zone information for a directory listing of computer files, comprising:

receiving a directory listing command for listing computer files within the directory;

and

displaying a directory listing of computer files, wherein the directory listing of computer files includes time and time zone information associated with each of the computer files;

selecting a sorting order;

sorting the directory listing of computer files in accordance with the sorting order, wherein the directory listing is sorted by specified regions, wherein the specified regions comprise geographic areas defined by longitude and latitude information; and

displaying the directory listing of computer files in accordance with the sorting order.
