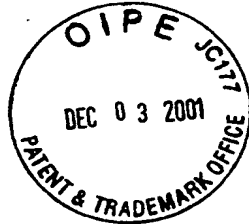

Document A6 relates to the evaluation of the patent-qualification considered in block letters.

Document A8 relates to an imprintable image carrier material for thermal image transference.

Document A7 is a foreign counterpart to Document A3.
