

DETAILED ACTION

This action is in response to applicant's amendment filed 2/15/05. A telephone call was conducted with Mr. David Lee, the applicant's representative, on March 14, 2005 to discuss an error on the Office Action Summary page sent 1/14/05. Claim 7 was shown incorrectly objected to on the form. However, in the Office Action, only claims 9 and 10 are allowable subject matter. To correct the error, Applicant has agreed to cancel claim 7 without traverse. Therefore, claims 1-8 and 11-25 are canceled. Claims 9 and 10 are allowable.
