Continuation of 5. does NOT place the application in condition for allowance because: the prior art teaches the same co-polymers as the matrix layer of the transdermal composition and recites fentanyl as one of the compounds suitable for the composition. The general amounts taught by the reference are 0.1% to 30%. The preferred embodiment of the invention of the prior art is to have the drug be fully dissolved or the matrix be free of undissolved drug. Several solvents are taught by the prior art, including, DMSO, glycerol, propylene glycol and ethanol as well as lipophilic compounds (See page 9). Therefore, it is the position of the Examiner that it would be obvious to one of ordinary skill in the art to achieve full dissolution of the drug at the maximum amounts as taught by the reference. Furthermore, being that the components of the matrix layer are the same, the dissolution of the drugs in the matrix would be the same. Applicants' arguments to the contrary are unpersuasive.
