Continuation of 11. does NOT place the application in condition for allowance because:

Claims have not amended and applicants repeat the same arguments regarding WO '229 and US '849, therefore, the examiner maintains her position as previously presented by the final office action. Further applicants argue that Roy et al. teach the same copolymer claimed by applicants and shows that not all the fentanyl is dissolved as required by the present claims. In response to this argument, it is argued that the copolymer disclosed by Roy et al. comprises copolymer containing 72% 2-ethylhexyl acrylate and 28% vinyl acetate, and the instantly claimed copolymer comprises about 52% to about 60% isooctyl acrylate, about 35% to about 40% 2-hydroxyethyl acrylate, about 1% to about 4% macromonomer, and 0% to about 10% vinyl acetate by weight. Therefore, the claimed polymer is totally different from the copolymer disclosed by Roy et al., therefore, does not have the same solubility to fentanyl.
