2. Claims 1, 3, 4, 6, 7, 9, and 13-15 are allowed.

The following is an examiner's statement of reasons for allowance: Regarding claims 1, 4, and 7, over and above the previously cited art, it would be obvious to use the Format ID filed of a CIP packet (which is isochronous) to determine that a packet is audio data. See The Association of Musical Electronics Industry, "MIDI Media Adaptation Layer for IEEE-1394," Version 1.0, 2000. No art could be found, however, that would have rendered it obvious to further detect that the packet is also encrypted

All other claims are allowable based upon their dependence on an allowable base claim.
