REASONS FOR ALLOWANCE

1. The following is an examiner's statement of reasons for allowance: The Board of Patent Appeals and Interferences (Board) has stated that there is no suggestion to replace the felt belts in DE '048 or Schiel with a wire when these two references are taken view in view of Dahl and/or Meinander. The Board has suggested that it may have been obvious to add wire storage belts to the press system shown in DE '048 for the advantageous taught by Dahl at column 5, lines 15-24. DE '048 uses a single felted or double felted nip, last paragraph column 8 spanning column 9. The wire storage is one of three alternative storage structures, the other two are "foils and felts" which have large storage volume or capacity. There is no suggestion or motivation to add an additional wire to a press system where the other or second belt is a blind grooved or bored as presently claimed.
