1. This action is in response to communication filed 1/26/2005.

Allowable Subject Matter

2. Claim 1-78 are allowed.

3. The following is an examiner's statement of reasons for allowance: The prior art Dobbelaar, which was previously presented, teaches horizontal and vertical scroll bars but fails to teach panels being arranged into two bars of panels with a common focus panel at the intersection of the two bars of panels, each of the panels being linked to and identifying one of a calendar entry, group, or subgroup.
