<u>REMARKS</u>

Applicant notes with appreciation the telephone interview granted by the Examiner with the undersigned on July 20, 2004 and an Interview Summary related to this interview is submitted concurrently herewith. As noted in the Interview Summary, the Examiner and the undersigned agreed that the claims with certain amendments would be allowable. Applicant amended the claims as discussed in the interview on July 26, 2004 and sent the Amendment to the Examiner's personal fax number. However, since the Amendment was never sent to the official fax number, it was never entered. Applicant is now resubmitting these amendments and respectfully submits that the claims are in condition for allowance.

Applicant has cancelled claims 1-14 and 30-34. Applicant has amended claims 35 and 54 to state that the stabilizing rib is "directly under" the channel. Applicant has also added new claims 55 and 56 and these claims are supported by original Claim 1. Claims 57-60 have been added and correspond to original claims 30 and 32-34 except that they include the toneable conduit description from claim 35.

In addition to claims 35-60, Applicants have added two additional claim sets. Claims 61-86 correspond to claims 35-60 except that they state that the stabilizing rib supports the channel instead of stating that the stabilizing rib is "directly under" the channel. Similarly, Claims 87-112 correspond to claims 35-60 except that they state that the stabilizing rib is on the same radius as the channel instead of stating that the stabilizing rib is "directly under" the channel. Applicant respectfully submits that these claims are supported by the specification and drawings and requests entry of these amendments. Based on these amendments, Claims 35-112 are pending in the present application.

As discussed in the telephone interview, the combination of Sherlock, Pelzer and Nakamura fails to teach or suggest a stabilizing rib extending longitudinally along the interior surface of the wall, located radially inward from the channel, and "directly under", "supporting" or "on the same radius as" the channel. Accordingly, Applicant respectfully requests that the rejections based on these references be withdrawn.

Applicant respectfully submits that all the claims are in condition for allowance. Accordingly, a Notice of Allowance is respectfully requested in due course. If any minor
