  - ***wherein the specified time period is received from the network at the mobile station.***

#### ***Allowable Subject Matter***

**Claims 93-96** are allowed over the cited prior art Bonta et al. (U.S. Patent Number 6,337,983 B1).

The most relevant prior art of Bonta et al. teaches that rescue orders may be transmitted from the MS to the BS, wherein rescue orders contains timing information.

In contrast, with respect to **claims 93-96**, the instant application discloses that the time period information is received at the mobile station **"from"** the network.

Therefore, in combination with all of the limitations of **claims 93-96**, the claims are thereby allowable.


