## **REASONS FOR ALLOWANCE**

1. The following is an examiner's statement of reasons for allowance: The following is a statement of reasons for the indication of allowable subject matter: The instant application discloses a method of estimating an impulse response of an information transmission channel in a signal propagation environment. Prior art references show similar methods but fail to teach: "determining a time domain spreading parameter based up on the initial estimate", as in claims 15, 21, 27, 33, 38; "using the time domain spreading parameter to determine the useful number of coefficients comprises comparing the time domain spreading parameter with a plurality of predetermined spreading parameter values each corresponding to a different time domain spreading of the transmission channel", as in claim 19.
