Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments: Mr. Delucia presented arguments that the cited prior art fails to teach the limitations of claim 41, wherein Mr. Delucia referred Examiner to Fig. 6 and 9 of the present Application Specification in support of his argument. Examiner breifly reviewed the prior art, and indicated to Mr. Delucia that the primary reference appears not to meet all the limitations of claim 41, therefore, Examiner will perform an additional search upon receipt of Applicants response to the office action mailed out on 5/22/2007.
