Response to Amendment

1. The Notice of Non-Compliant Amendment mailed November 15, 2004 is hereby vacated as being improper. The amendment filed November 5, 2004 is improper for failing to comply with 37 CFR 1.173, which states in part:

Making amendments in a reissue application.

2) Claims . An amendment paper must include the entire text of each claim being changed by such amendment paper and of each claim being added by such amendment paper. For any claim changed by the amendment paper, a parenthetical expression "amended," "twice amended," etc., should follow the claim number. Each changed patent claim and each added claim must include markings pursuant to paragraph (d) of this section, except that a patent claim or added claim should be canceled by a statement canceling the claim without presentation of the text of the claim.

It should be noted that only amended, canceled and newly added claims as of the current filed amendment paper should appear in the amendment listing of claims.

Applicant is urged to carefully consider and prepare the next response in accordance with 37 CFR 1.173.

2. Thus, the timely submission filed on November 5, 2004 is not fully responsive to the prior Office action because the amendment lists claims 41,42,48,49 and 57 as new and claims 43-47,50-56, and 58-81 as cancelled. This is contradictory and improper. Additionally, previously amended claims are re-presented showing the same amendment. This is improper in reissue applications. Since the submission appears to be a *bona fide* attempt to provide a complete
