

IN THE CLAIMS

Please cancel claims 1 through 23, 28 through 31 and 33 without prejudice or disclaimer of their subject matter, and amend claims 24 through 27, 32, 34, 35 and 37 through 44, as follows:

Claims 1-23. (Canceled)

1 24. (Currently Twice Amended) A ~~bag~~ backpack, comprising of:

2 a back wall;

3 a ~~first unit~~ hook connected to a top side of said back wall, said ~~first unit~~ hook capable of
4 hanging said back wall to an ~~external~~ object, ~~the external object being external~~ to said ~~bag~~
5 backpack;

6 a plurality of compartments on a front surface of said back wall, the plurality of
7 compartments including a front portion ~~comprising~~ comprised of netted material accommodating
8 a circulation of air within said compartments, said compartments accommodating a plurality of
9 objects;

10 a pair of shoulder straps disposed a predetermined distance from each other along the
11 longitudinal side of a ~~bottom portion of~~ the back surface of said back wall to accommodate a
12 carrying of said ~~bag on the back of a user~~ backpack by the shoulders and the back of a user; and

13 wherein said backpack is secured by a fastening unit after said backpack is folded to a
14 closed position.

15 ~~a fastening unit securing one end said back wall with the other end when said back wall is~~

16 ~~folded.~~

1 25. (Currently Twice Amended) The ~~bag~~ backpack of claim 24, further comprising a first
2 side wall and a second side wall ~~extending from the bottom portion~~ attached to a first and second
3 side of said back wall respectively, the first and second side walls disposed on opposite sides of
4 said back wall, said first and second side walls being fastened to the sides of a top portion of said
5 back wall when said back wall is folded.

1 26. (Currently Twice Amended) The ~~bag~~ backpack of claim 25, further comprised of ~~the~~
2 ~~bottom portion of said back wall including a first extended portion and a second extended portion~~
3 ~~extending on said opposite sides of said back wall, the first extended portion of said back wall~~
4 ~~connected and forming an angle with the first side wall, the second extended portion of said back~~
5 ~~wall connected and forming an angle with the second side wall, a width of the bottom portion of~~
6 ~~said back wall being greater than the width of a top portion of said back wall~~ a bottom panel
7 attached at an angle to said backwall, and to said first and second sidewalls.

1 27. (Currently Twice Amended) The ~~bag~~ backpack of claim 26, wherein when said back
2 wall is folded, a portion of said back wall that is folded is substantially flat.

Claims 28-31. (Canceled)

1 32. (Currently Once Amended) The ~~bag~~ backpack of claim 26, further comprising a
2 ~~second unit~~ means for accommodating the hanging of hangers for clothes ~~disposed~~ on the top
3 portion of the front side of said back wall.

Claim 33. (Canceled)

1 34. (Currently Once Amended) The ~~[[bag]]~~ backpack of claim 24, further comprising ~~[[a]]~~
2 at least one strap holding securing an object ~~within to~~ said ~~[[bag]]~~ backpack.

1 35. (Currently Twice Amended) A ~~[[bag]]~~ backpack, comprising:
2 a back wall;
3 a left wall and right wall extending from at least a portion of said back wall;
4 a bottom portion ~~formed from~~ attached to a bottom of said back wall and said bottom
5 portion connecting between a bottom of said right wall and said left wall;
6 a first wall extending from said bottom portion and assisting in holding ~~at least~~ a sufficient
7 portion of said left and right walls together ~~to form~~ forming a chamber bottom compartment;
8 a plurality of compartments on a front surface of said back wall, said plurality of
9 compartments comprising a front portion comprising of at least a partially see-through material
10 accommodating a circulation of air within said compartments, said compartments accommodating
11 a plurality of objects, said plurality of compartments being disposed on a single plane
12 accommodating full accessibility and a view of the objects within said plurality of compartments

13 when said backpack is in an open position, said back wall folding to close said ~~[[bag]]~~ backpack,
14 said compartments disposed from a top portion of the front surface of said back wall to a bottom
15 portion of said back wall; and

16 at least one ~~strap disposed~~ back strap on the back an external surface of said ~~back wall~~
17 backpack to accommodate ~~[[a]]~~ shoulder and back transport of said ~~[[bag]]~~ backpack, ~~with said~~
18 ~~at least one strap being a backpack strap accommodating the transport of said bag on a back of a~~
19 ~~user.~~

Claim 36. (Cancelled)

1 37. (Currently Twice Amended) The ~~[[bag]]~~ backpack of claim 35, further comprising a
2 first unit connected to a top side of said back wall, said first unit capable of hanging said back wall
3 in the single plane to an external object.

1 38. (Currently Twice Amended) The ~~[[bag]]~~ backpack of claim 37, further comprising a
2 ~~first unit~~ strap accommodating the hanging of garments along a length of said back wall.

1 39. (Previously Added) A backpack, comprising:
2 a back member having a top, bottom and two sides;
3 curved side members affixed to a portion of each of said two sides of said back member
4 ~~and extending from a front side of said back member;~~

5 a bottom member connected to said bottom of said back member and a bottom of each of
6 said curved side members, said bottom member extending from said front side of said back
7 member, ~~said back member, said curved side members and said bottom member defining an~~
8 ~~internal volume;~~

9 a zipper positioned on said top of said back member, a portion of each side of said back
10 member [[and]] on said curved side members and said bottom member for selectively connecting
11 and disconnecting said top and sides of said back member to said curved side members and said
12 bottom member; and wherein said back wall folds to form a front panel of a backpack
13 configuration, when fastened shut, a plurality of compartments formed on a front side of said back
14 member at spaced apart locations, said compartments being within [[said]] an internal volume
15 when said zipper connects said top and sides of said back member to said curved side member, and
16 said bottom member, said back member forming a single plane when in an opened position to
17 accommodate an access and view of objects within said plurality of compartments; and
18 backpack straps positioned on a back side of said back member of said backpack.

1 40. (Currently Once Amended) The backpack of claim 39, further comprising a hook
2 connected to said back member for hanging said backpack when said ~~zipper is selectively~~
3 ~~disconnected with said top of said back member from said curved side members and said bottom~~
4 ~~member~~ backpack is unzipped.

1 41. (Currently Once Amended) The [[bag]] backpack of claim 27, with said back wall

2 being folded by the top portion of said back wall being folded frontally downwards towards the
3 ~~bottom~~ front portion of said ~~back wall~~ bottom panel accommodating the fastening of one end of
4 said back wall to the other end when said back wall is folded, and accommodating said first and
5 second side walls extending from the bottom portion of said back wall being fastened to the sides
6 of the top portion of said back wall when said back wall is folded.

1 42. (Currently Once Amended) The ~~[[bag]]~~ backpack of claim 27, further comprising a
2 ~~bottom~~ front wall formed at the front edge of the bottom portion panel of said ~~back wall~~ backpack
3 and assisting in holding said first and second side walls together to form a bottom ~~chamber~~ cavity
4 for holding objects at the bottom.

1 43. (Currently Once Amended) The ~~[[bag]]~~ backpack of claim 38, with said back wall
2 folding to close said bag by folding the top portion ~~of the front surface~~ of said back wall to the
3 ~~front surface~~ edge of ~~[[the]]~~ a bottom portion of said back wall to couple with said bottom portion
4 formed from a bottom of said backwall, said left wall and said right wall extending from the
5 bottom portion of said back wall and upwards from said bottom of said backwall forming a bottom
6 of said backpack.

1 44. (Currently Once Amended) The backpack of claim 40, with said back member
2 selectively connecting and disconnecting said ~~top of said~~ back member to said curved side ~~member~~
3 members and ~~[[said]]~~ the front of said bottom member by folding said back member frontally

4 downwards toward the bottom member to fasten and close said backpack and [[opens]]
5 unfastening said backpack to unfold said back member upwards to a hanging position.
