

AMENDMENTS TO THE CLAIMS

1-68. (Canceled)

69. (New) A system comprising:

a set of seller computing devices configured to communicate with a seller interface application, the set of seller computing devices specifying types of wood products, quantities of available inventory of wood products, and a minimum number of wood products that must be purchased to complete a transaction;

a buyer computing device configured to communicate with a buyer interface application, the buyer computing device initiating a query for the transaction and receiving a subset of seller computing devices that are available to transact with the buyer computing device to facilitate the transaction; and

a transaction processing server configured to execute the buyer interface application and the seller interface application to broker transactions of wood products, the transaction processing server generating the subset of seller computing devices.

70. (New) The system of Claim 69, further comprising a transaction database configured to store identities of the set of seller computing devices, an identity of the buyer computing device, and information connected with the transaction.

71. (New) The system of Claim 69, further comprising a shipper computing device configured to facilitate a shipper to ship wood products to complete the transaction, the shipper computing device modifying the transaction to incorporate shipping requirements.

72. (New) The system of Claim 69, further comprising an insurance computing device configured to facilitate an insurer to insure the transaction, the insurance computing device modifying the transaction to incorporate insurance requirements.

73. (New) The system of Claim 69, further comprising a warehouse provider computing device configured to facilitate warehousing of wood products, the warehouse provider computing device modifying the transaction to incorporate warehousing requirements.

74. (New) The system of Claim 69, further comprising a manufacturer computing device configured to facilitate manufacturing of wood products, the manufacturer computing device modifying the transaction to incorporate manufacturing requirements.

75. (New) The system of Claim 69, further comprising a customs agent computing device configured to facilitate customs requirements, the customs agent computing device modifying the transaction to incorporate customs requirements.

76. (New) A method comprising:
receiving a selection of a seller of wood products from a number of advertisements displayed on a buyer computing device; and
executing a correlation application in a transaction database to correlate quantity, product identifiers, or both sent by a seller computing device with quantity, product identifiers, or both sent by the buyer computing device to facilitate a transaction of wood products between a buyer and a seller.

77. (New) The method of Claim 76, further comprising obtaining, prior to execution of acts claimed above, a set of sellers inventory of wood products that are selected from a group

consisting of wood product quantities, wood product identifications, and a minimum number of wood products that must be purchased to complete a transaction.

78. (New) The method of Claim 77, further comprising generating a subset of the set of sellers that are available to facilitate the transaction with the buyer.

79. (New) The method of Claim 76, further comprising including businesses that may modify the transaction by executing a three-tiered process, a first tier being business classifications, a second tier being geographic regions, and a third tier being identities of businesses.

80. (New) The method of Claim 76, further comprising excluding businesses that may modify the transaction by executing a three-tiered process, a first tier being business classifications, a second tier being geographic regions, and a third tier being identities of businesses.

81. (New) The method of Claim 76, further comprising specifying by the seller computing device to include distributors to modify the transaction but not retail sellers.

82. (New) The method of Claim 76, further comprising maintaining inventory of a buyer by issuing a supplier order when the inventory of the buyer is below a threshold.

83. (New) A computer-readable medium having instructions stored thereon for implementing a method comprising:

receiving a selection of a seller of wood products from a number of advertisements displayed on a buyer computing device; and

executing a correlation application in a transaction database to correlate quantity, product identifiers, or both sent by a seller computing device with quantity, product identifiers, or both sent by the buyer computing device to facilitate a transaction of wood products between a buyer and a seller.

84. (New) The computer-readable medium of Claim 83, further comprising obtaining, prior to execution of acts claimed above, a set of sellers inventory of wood products that are selected from a group consisting of wood product quantities, wood product identifications, and a minimum number of wood products that must be purchased to complete a transaction.

85. (New) The computer-readable medium of Claim 84, further comprising generating a subset of the set of sellers that are available to facilitate the transaction with the buyer.

86. (New) The computer-readable medium of Claim 83, further comprising including businesses that may modify the transaction by executing a three-tiered process, a first tier being business classifications, a second tier being geographic regions, and a third tier being identities of businesses.

87. (New) The computer-readable medium of Claim 83, further comprising excluding businesses that may modify the transaction by executing a three-tiered process, a first tier being business classifications, a second tier being geographic regions, and a third tier being identities of businesses.

88. (New) The computer-readable medium of Claim 83, further comprising maintaining inventory of a buyer by issuing a supplier order when the inventory of the buyer is below a threshold.
