DETAILED ACTION

Amendment

1. Receipt is acknowledged of the amendment after final filed on September 1, 2005. In the
5 amendment claims 1-6, 8-10, and 16-20 were canceled, and claims 7 and 11-1~~3~~^{3 MK} were amended.
Currently, claims 7 and 11-15 remain for examination.

Allowable Subject Matter

2. Claims 7 and 11-15 are allowed.
- 10 3. The following is a statement of reasons for the indication of allowable subject matter: the
claims are directed at a transponder moveably implanted into a pocket on a spindle sleeve. As
disclosed in previously cited reference to Aslam, Epstein and Kleinfelter, a data system
comprising an elastomeric product is well known in the art. However, the references, taken
alone or in combination, fail to suggest or teach a particular structure wherein the sleeve
15 comprises a sealable pocket bondable to the elastomeric body. The structure further discloses a
toothed profile as set forth in the claims.
