Response to Amendment

The amendment filed on December 11, 2003 under 37 CFR 1.131 is sufficient to overcome the Allen reference.

Allowable Subject Matter

Claims 78-126 allowed.

The following is an examiner's statement of reasons for allowance:

Claims 78-88 and 122-126 are allowed, because, Ito alone or in combination with Allen failed to teach wherein a second communication network, coupled to a second interface, for carrying the AV data has a higher bandwidth than a first communication network for carrying the request and metadata as recited in the claims.

Claims 89-121 are allowed for same reason provided in the previous office action.
