WHEREAS, I, Martin Philip Riddiford, a British citizen, residing at 23 Elfindale Road, London SE24 9NN, have invented certain new and useful improvements in a COMPUTER WITH A PEN OR TOUCH SENSITIVE DISPLAY for which I have filed an application for Letters Patent in the United States, Application No. 10/005,751, filed November 7, 2001, This application is a continuation of prior application Serial No. 09/053,329, filed April 1, 1998, entitled "Computer With a Pen or Touch Sensitive Display," now abandoned. That application Serial No. 09/053,329 is [are] hereby incorporated by reference in its entirety into this application. Application Serial No. 09/053,329 is a continuation-in-part of application Serial No. 08/723,882, filed September 23, 1996 entitled "Computing Equipment Casing Having Hinged, Spring Loaded, and Sliding Leaves," and now issued at U.S. Patent No. 5,742,425, issued April 21, 1998, hereby incorporated by reference in its entirety into this application. Application 08/723,882 (now U.S. Patent No. 5,742,425) claims foreign priority benefit of United Kingdom Application No. 9519556, and this application hereby claims foreign priority benefit of United Kingdom Application No. 9519556 (hereinafter collectively referred to as "said Application");

AND WHEREAS, PSION DIGITAL LIMITED (hereinafter "ASSIGNEE"), a British Corporation, with its principal place of business at Psion House, 19 Harcourt Street, London WIH 1DT, desires to acquire the entire right, title, and interest in and to the said improvements and the said Application:

AND I HEREBY covenant and agree that I will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY acknowledge that I have sold, assigned, transferred and set over and do hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title, and interest to all provisional rights in the said Application as set forth in Section 154(d) of Title 35 of the United States Code.
