DETAILED OFFICE ACTION

1. Claims 1-11 have been canceled.

Allowable Subject Matter

2. Claims 12-14 are allowed.
3. The following is a statement of reasons for the indication of allowable subject matter: No prior art of record discloses or fairly suggest an extended text label for a capped tube container in combination, wherein the capped tube container includes a

product dispensing end having a dispensing cap and a filling end opposite the dispensing end, the combination comprising: a capped tub container including a crimp method seal at the filling end that is crimped subsequent to filling the capped tube container with a selected product; an extended text label securely joined to the filling end of the container by way of the crimp method seal; and a pliable tongue extending outwardly for the label such that the tongue is joined to the filling end of the capped container at the seal; a tear-off portion; and including all of the other limitations of the independent claim.

The Garill et al reference is the closest reference to read on applicant's invention. However, Garill et al does not disclose a pliable tongue extending outwardly for the label such that the tongue is joined to the filling end of the capped container at the seal and a tear-off portion for permanently removing the text label.


Conclusion

The prior art made of record and not relied upon is considered pertinent to applicant's disclosure. Flaig discloses a similar extended text label. De Cardenas et al discloses a similar combination text label and tub container.
