

DECLARATION



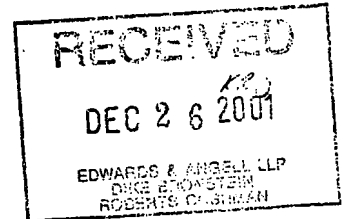
