## DETAILED ACTION

### *Response to Arguments*

1. Applicant's arguments, see page 9, filed 6/20/05, with respect to objection to claims 8 and 18 have been fully considered and are persuasive. The objection to claims 8 and 18 of Office Action, dated 3/18/05, has been withdrawn in view of amendment.
2. Applicant's arguments, see pages 10 - 12, filed 6/20/05, with respect to 103 rejection of claim 1 have been fully considered and are persuasive. The 103 rejection of claim of Office Action, dated 3/18/05, has been withdrawn.

### *Allowable Subject Matter*

3. Claims 1 – 19 are allowed.
4. The following is an examiner's statement of reasons for allowance:

As per applicant's arguments, see pages 10 - 12, filed June 20, 2005, claims 1 – 19 are now allowed.

***Other Cited Prior Art***

5. The prior art made of record and not relied upon is considered pertinent to applicant's disclosure. Phanse (US-6795494), Abdelilah (US-6661837), Long (US-6560276), Bjarnason (US-6434233), Zhang (US-6404809), and Olafsson (US-6317419) all disclose modem apparatus that show variations of modem implementations germane to applicant's field of invention. Sayar (US-4896334) discloses a modem apparatus with a timing recovery apparatus. NPL references show various aspects of timing recovery and Farrow phase shifters.
