DETAILED ACTION

Response to Amendment

In view of applicant's amendment filed 09 June 2006, rejections under 35 U.S.C. § 112,
 2nd paragraph are withdrawn.


Allowable Subject Matter

2. Claims 58-70 are allowed over the Prior Art of record.

3. The following is an examiner's statement of reasons for allowance: The primary reasons for allowance of the independent claims is the inclusion of the limitations and/or method steps of an apparatus/method for determining flow rates in a multiphase fluid employing first, second and third sensor pairs, mounted on a deployable arm supported by a main body portion, deployed to occupy the entire diameter of the well and measuring the local speed of the flowing fluid and the local proportions (i.e. phases) of the flowing fluid at particular locations recited in the claim, wherein the locations are in alignment with each other on a line parallel to the longitudinal axis of the well.

4. The closest Prior Art reference is US 5,574,263 to Roesner, which discloses a method/device for measuring multiphase fluid flow rates in a well, however, only mounts single sensor across the diameter of the well, parallel to the longitudinal axis of the well (see Fig. 6 below), not pairs of sensor, measuring the both the local speed and proportions of the fluid flow, and which fails to provide any teaching/motivation to do so.
