DETAILED ACTION

Allowable Subject Matter

Claims 1-136 are allowed.

The following is the examiner's statement of the reasons for allowance. The amended claims feature sending a data request to a computer system, where the computer system looks up whether at least portions of the data have been received by peer computers. The computer system then directs the peers to encode and send the data portions to the requesting computer, and the peers complete the download of the remaining portions they have left to complete the file. The requesting computer then receives the different partial portions of the encoded data from multiple peers, decodes and recreates the requested data, and saves it into memory. In sum, the partial file transfer by a peer is performed before the file download is completed at the peer. In view of the inclusion of the narrowly claimed features, specifically the downloading and uploading the partial files simultaneously, it is believed that the claimed invention is novel. The examiner was unable to procure prior teachings of such features as claimed, and could not render said features obvious to one of ordinary skill in the art, without the use of impermissible hindsight constructions. Applicant's arguments regarding the outstanding claims were also persuasive. It is therefore the examiner's belief that the claimed invention, as set forth in the above claims, does indeed possess novelty.
