DETAILED ACTION

Allowable Subject Matter

Claims 1-136 and 138-140 are allowed.

The following is an examiner's statement of reasons for allowance: The amended claims feature the distribution of data to a plurality of computers, comprising sending a first portion of the data to a first computer. Next, a second portion of the data is sent to a second computer, where the second portion of data includes sections of data not sent to the first computer. After the sending to the first and second computers has begun, a request for the data is sent from a requesting computer to a targeted computer system. A look-up list is accessed to identify the computers that have previously requested the data, and before all of the data has been received at the first and second computers, requests to the first and second computers are sent. The first portion and at least of some of the second portion is then sent from the first and second computers respectively to the requesting computer. The requesting computer receives the first portion of the data and at least some of the second portion, where the data from the second computer includes data not sent to the first computer. The requesting computer then recreates and saves the data. Because data is transferred between computers before downloading is complete at the first and second computers, and because the first and second computers contain dissimilar data, it is believed that the claimed invention is novel. The examiner was unable to procure prior teachings of such features as claimed by the amended claims and could not render said features obvious to one of ordinary skill in the art, without the use of impermissible

hindsight constructions. Additionally, Applicant's remarks regarding the claim amendments and the provided prior art references' deficiencies are persuasive, in that none of the references, taken singly, or in combination, teach the newly claimed features. It is therefore the examiner's belief that the claimed invention does indeed possess novelty.
