A Notice of Abandonment, Form PTO-1432, was mailed on December 7, 2007 in patent application Serial Number 10/038,796. The Notice of Abandonment alleged that applicant failed to file a response to the Board Decision dated November 29, 2007 and that the period for seeking court review of the decision has expired with no allowable claims in the file.

Review of the file history shows mailing of the Board Decision dated November 29, 2007. However, the period for court review of the decision runs two months from the Board Decision of November 29, 2007, or until January 29, 2008.
