1. This Office action is in response to the amendment filed March 21, 2005. Claims 1-3 have been cancelled and new claim 4 has been entered. Claim 4 is pending. The Examiner has approved the proposed drawing changes.

- 2. Claim 4 is allowed.
- 3. The following is an examiner's statement of reasons for allowance: the claim recites a key detection system that places the conductors on the columns at a higher potential than the conductors on the rows and lowers the potential on the column, when the pressing of a key connects a row with a column, to detect the particular key pressed. Such a combination is not taught or suggested by the prior art of record.
