DETAILED ACTION

1. This action is responsive to the amendments filed April 3, 2008. Claims 3-5, 7, 12, 13, 15, and 48-50 have been canceled; claims 2, 8-10, and 51 have been amended.
2. The 35 USC section 101 rejection to claims 2-5, 7-13, and 48 is withdrawn in view of Applicant's amendments.
3. Claims 2, 8-11, 51-53, and 55 have been examined, and claims 8-11, 51-53, and 55 now are being allowed (renumbered 1-8).

Examiner's Amendment

Examiner's Statement of Reasons for Allowance

6. As Applicants pointed out in the Remarks, the prior art of record (Avvari, Silva, and Duggan) do not disclose and/or fairly suggest at least claimed limitations "calculating an execution time for the test job-package and if the calculated execution time exceeds a predetermined allowable execution time, automatically building and assigning a different test job-package to the available test client with tasks from the test packet", and in as such a manner as recited in independent claim 51 (Remarks, pages 6-8).

These claimed limitations are not present in the prior art of record and would not have been obvious, thus claims 8-11, 51-53, and 55 are allowed (renumbered 1-8).
