The proposed amendment raises new issues that would require further consideration and/or search. Applicant amended “such that in a first stage” to “configured to provide in a first stage” is change scope of the invention.

Applicant argues:

1) There is never any category filtering and then filtering within categories. Instead, information of interest to communities is filtered and information of interest to individual is filtered.

In response to argument 1), Examiner respectfully disagrees with applicant argument regarding category filtering. Lang teaches first processor 52 uses to filtering duplicate informons, e.g. same information from different source (see Lang: col.8 lines 55-65) and second processors filter raw information and extract proposed community informons (see col.9 lines 15). Lang clearly teaches filtering within categories of information by filtering the duplicated information come from the DataStream 15 (see Lang: Fig.1) and filtering raw information (second stage filtering) before proposed to the community user level.
