

**REMARKS**

Claims 1-9 are pending in this application. Claims 10-18 were previously cancelled. No claims have been amended.

Claims 1-9 have been provisionally rejected based on the judicially created doctrine of nonstatutory double patenting over claims 1-9 of U.S. Patent Appl. No. 10/501,498. To address this rejection, Applicant is submitting a Terminal Disclaimer over any patent which issues from the cited patent application with this Response.

Applicant thanks the Examiner for withdrawing the rejection of claims 1-9 under 35 U.S.C. §103(a).


