Continuation of 13. Other: Applicants argue that Sobeski et al fails to teach generating the updated information on the basis that the server does not initiate and generate the updating of the button information. However, nowhere in the claim language of claim 1 does it suggest initiating the updating of the button information. In fact the word initiate or any form thereof is lacking from the claim language. Furthermore, claim 2 suggests that the client instructs the buttons to be update, or initiates. As argued in the previous office action Sobeski does in fact teach generating the updated button information specifically that the toolbars does not receive the (customized button information) from the web browser but rather from a cooperating server (Column 5 lines 36-49)..
