

Continuation of 13. Other: Enclosed please find the IDS's (1/14/03 and 10/10/04) which have been considered by the Examiner. The Applicant's amendments and arguments have been considered; however they are not deemed to be persuasive. The Allocation table in the BRSM layer 101 is the same memory including the designated blocks of memory that are assigned and accessed by the threads since the allocation table is part of the VRSM layer 101 for allocating data structure of the specified size from the heap of virtually reliable memory (again, see column 5, lines 33 et seq.); and the Snider's exclusive write capabilities are equivalent to the usage information since only one processor or thread can write access that particular memory at any one time (e.g. see column 6, lines 65 et seq.; also column 7, lines 7 et seq.).
