

### ***EXAMINER'S AMENDMENT***

An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicant, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it **MUST** be submitted no later than the payment of the issue fee.

The application has been amended as follows:

#### **IN THE CLAIMS**

Claim 36, line 2, the word "the" has been deleted.

Claim 49, line 3, the word "the" has been deleted.

### ***REASONS FOR ALLOWANCE***

The following is an examiner's statement of reasons for allowance:

Claims **2-14 and 29-55** are allowable over the prior art of record because the prior art does not teach or suggest a process for continuous nickel plating of an aluminum conductor, comprising the steps of electrolytically pre-treating, electrolytically plating and transmitting as presently claimed, esp., the step of transmitting at least the nickel plating current  $I_n$  to the conductor through a mechanical electrical contact which contacts the conductor between the pre-treating bath and the plating bath.

The prior art does not contain any language that teaches or suggests the above. Hansson does not teach transmitting at least the nickel plating current  $I_n$  to the

conductor through a mechanical electrical contact which contacts the conductor between the pre-treating bath and the plating bath. Hansson teaches that the compartment **14** between two compartments **2, 3** is a buffer compartment (col. 5, lines 7-10). Therefore, a person skilled in the art would not have been motivated to adopt the above conditions, and a prima facie case of obviousness cannot be established.
