DETAILED ACTION

Allowable Subject Matter

1. Claims 1, 2, 4-10, 12-36 and 49 are allowed.
2. The following is an examiner's statement of reasons for allowance: The prior art of record does not teach or suggest the applicant's invention as claimed in detail wherein said translating occurs without buffering the packet; mapping the fields of the packet to a new packet in accordance with a second protocol without buffering the packet; said translating the packet by mapping at least some of the fields do not require the packet to be buffered; an ingress linecard placing a virtual target descriptor identifier and flow ID in a local header of a packet and to translate the format of the packet from a first protocol to a second protocol.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
