

## DETAILED ACTION

### *Reasons for Allowance*

1. The Terminal Disclaimer filed 4/29/2005 over U.S. Patents 6,605,102 and 6,712,835 as well as application serial number 10/051,565 has been approved.

3. The following is an examiner's statement of reasons for allowance: the prior art reference has failed to disclose or suggest a method for using a filter device, and the filter device is carried by a guidewire and restrained by a tubular sheath as recited in the independent claims 1, 40 and 45.

Claims 1-19, 40-45 and 47-50 are allowed.


