### **DETAILED ACTION**

This Office action responds to the amendment in paper no. 11, filed on 3/5/2004, and to the supplemental amendment in paper no. 14, filed on 4/21/2004.

The present Office action is made with all the suggested amendments being fully considered. Accordingly, pending in this Office action are claims 1-30.

#### ***Reasons for Allowance***

2. Claims 1-30 are allowed.

3. The following is an examiner's statement of reasons for allowance:

None of the references of record shows or can be fairly combined to render obvious an integrated circuit comprising two nonvolatile memory devices adjacent to each other in a row direction and sharing an impurity diffusion region, wherein each memory device comprise first and second control gates as sidewalls of a word gate, and wherein a pair of first and second control gates facing each other with the impurity

diffusion layer interposed between them are connected to each other surrounding the diffusion layer and connected to a common contact section.
