The application has been amended as requested in the communications filed December 7, 2004 and February 17, 2005. Accordingly, claims 2-4, 9, 35, and 36 have been amended, and claims 1, 6-8, 11-20, 23-26, 28-34, 37-48, and 50 have been canceled.

Since claims 2-5, directed to crystal of IGF-1 protein of SEQ ID NO: 1, have been placed in condition for allowance, the restriction between the crystal of Group I and methods of its use of Groups III and IV in the Office action mailed June 9, 2004 has been vacated in accordance with *in re Ochiai*. Thus, claim 36, directed to the use of the crystal in obtaining a three-dimensional structure of IGF-1 of SEQ ID NO: 1 has been included with the claims being examined in this Office action.

Claims 2-5, 9, 10, 21, 22, 27, 35, 36, and 49 are pending and under consideration.
