

Examiners Perungavoor and Zand are thanked for the interview, which was conducted with Applicants' representative, Mr. Hunter, on February 13, 2006 (please note that the Examiner's Interview Summary is in error in giving the interview date as February 15, 2006). During the interview, Examiner Zand indicated that independent claims 13, 26, and 31 were in condition for allowance, and that independent claims 1, 22, and 24 would likely be allowable if a feature of claim 5 were added to claims 1 and 22, and a corresponding feature of claim 25 were added to claim 24.




