Remarks: The proposed amendments to claims 1 and 10 raise new issues since the additional limitation specifies that a point in time for the apparatus to be in a condition to be singulated is defined to be at least after material removal processes are completed. The added limitation will at very least require further consideration and search before a proper determination of patentability can be made. Applicant's remarks have been considered, however, they do not place the application in condition for allowance because they are generally directed to features contained in the proposed amendment, which will not be entered. As a cautionary note, Applicant is requested to thoroughly consider the additional limitation in claims 1 and 10 of the proposed amendment because it would seem that "process operations of material removal" CANNOT be completed at any point before singulation, i.e., during the process for singulating/dicing, material removal must occur in order to acquire individual dies/chips, therefore, at least one additional "removal process" must be performed, accordingly, the additional limitation could not be realized. Also, it would not be clear whether "process operations of material removal" should be interpreted to mean "all material-removing processes" or "any material-removal process which occurs before the apparatus is in condition to be singulated".
