DETAILED ACTION

The reply filed 1/7/05 consists of amendments to claims 2, 3, 6, 8, 13, 14, 20, cancellation of claims 1, 4, 5, 7, 12, 15-19, addition of new claims 21-26, submittal of corrected drawings and remarks related to rejection of claims.

Drawings

The drawings were received on 1/07/05. These drawings are approved.

Allowable Subject Matter

Claims 2, 3, 6, 8, 9, 10, 11, 13, 14, 20-26 allowed.

The following is an examiner's statement of reasons for allowance: the prior art of record does not disclose or suggest the power generating and control system for a vehicle detecting deceleration of the vehicle wherein the first power supply comprising a main battery for the vehicle connected in every operating state to said generator and a second power supply being connected to said generator only when a power supply condition is satisfied.

Conclusion

The prior art made of record and not relied upon is considered pertinent to applicant's disclosure. Patent JP 409252546 A discloses a method of regenerating deceleration energy of vehicle and its device wherein after termination of the


deceleration state, the generator is stopped and power is supplied from the capacitor to the electric load and when the capacitor voltage value accords with the lead storage battery voltage, the lead storage battery is connected to the generator.
