A person shall be entitled to a patent unless --

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

2. Claims 1-4 are rejected under 35 U.S.C. 102(b) as being clearly anticipated by either ✓ DiGiovanni et al, figure 1A and columns 1-3; Sugaya et al (IEICE) at figures 5-6; or Fake et al, figures 1-2 and columns 1-2 ).

3. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless --

(a) the invention was known or used by others in this country, or patented or described in a printed publication in this or a foreign country, before the invention thereof by the applicant for a patent.

4. Claims 1-4 are rejected under 35 U.S.C. 102(a) as being clearly anticipated by either Sugaya et al (OAA), figures 1-3 or Meli et al at pages 2, 6, 7 and figures 1, 3, 6, and 11.

5. In view of the Terminal Disclaimers filed by Applicant the rejection made in the first Office action is hereby withdrawn.
