

Continuation of 11. does NOT place the application in condition for allowance because: All of the arguments presented in the Request for Reconsideration were addressed in the Final office action dated 12/10/04 except the following: Figure 5 of DiGiovanni "simply shows that the difference in output power increases between extreme channels and the center channels as the number of amplifiers increases." (pg. 9, lines 10-12). This argument is found not convincing because 'substantially equal gain' is claimed. The Examiner considers the gain of figure 5 to be substantially equal..
