## DETAILED ACTION

### *Drawings*

1. The subject matter of this application admits of illustration by a drawing to facilitate understanding of the invention. Applicant is required to furnish a drawing under 37 CFR 1.81. No new matter may be introduced in the required drawing. Applicant should note that drawings must show the details as described in the specification. Any structural detail that is essential for a proper understanding of the disclosed invention should be shown in drawing. MPEP § 608.02(d). A proposed drawing or drawings are required in reply to the Office action to avoid abandonment of the application. Any objection to the drawings will not be held in abeyance.

### *Claim Rejections - 35 USC § 112*

2. The following is a quotation of the second paragraph of 35 U.S.C. 112:

The specification shall conclude with one or more claims particularly pointing out and distinctly claiming the subject matter which the applicant regards as his invention.

3. Claim 1 is rejected as failing to define the invention in the manner required by 35 U.S.C. 112, second paragraph.

The claim is narrative in form and replete with indefinite and functional or operational language. The structure, which goes to make up the device, must be clearly and positively specified. The structure must be organized and correlated in such a manner as to present a complete operative device. The claim(s) must be in one sentence form only. Note the format of the claims in the patent(s) cited.

4. Claim 1 is rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention.

Regarding claim 1, line 2 the term “the connecting” (i.e.; connection) of a controlled braking device lacks antecedent basis.

Regarding claim 1, line 3 the term “the amount” of braking device lacks antecedent basis.

#### *Claim Rejections - 35 USC § 102*

5. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(e) the invention was described in (1) an application for patent, published under section 122(b), by another filed in the United States before the invention by the applicant for patent or (2) a patent granted on an application for patent by another filed in the United States before the invention by the applicant for patent, except that an international application filed under the treaty defined in section 351(a) shall have the effects for purposes of this subsection of an application filed in the United States only if the international application designated the United States and was published under Article 21(2) of such treaty in the English language.

6. Claim 1 is rejected under 35 U.S.C. 102(e) as being anticipated by Howard ‘395.

Howard discloses a system which comprises a connection of a controlled braking (resistance) device to a vehicle steering gear that includes means for controlling the amount a resistance (braking) generated by the controlled braking device (column 3, line 55-60 and column 4, line 65 through column 7) as best understood; whereby inertia of a fluid is induced into the vehicles’ steering gear.

*Conclusion*

7. The prior art made of record and not relied upon is considered pertinent to applicant's disclosure.


Robertson et al '884 and Howard '193, '028, '582, '519 and '520 disclose a steering system having a control means for inducing a fluid braking means into the steering gear of the vehicles steering system as claimed.
